## SCHEDULING WORKSHOPS

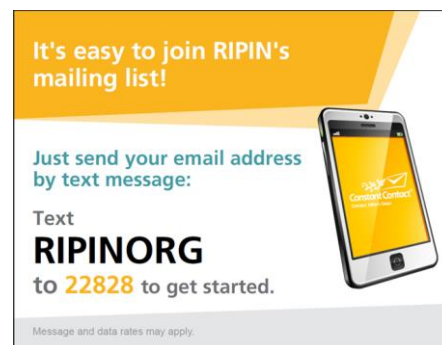

## SPECIAL EDUCATION & DISABILITY

### ***Basic Rights in Special Education (Children and Youth Ages 3-21)***

This workshop focuses on how to access special education and related services for children with disabilities. Participants will learn the laws that affect special education in Rhode Island and will receive an overview of parents' rights and responsibilities. **(2 hours) Also available in Spanish.**

### ***Bullying and Harassment of Students with Disabilities – What Parents and Educators Need to Know***

Students with disabilities are two to three times more likely to be bullied than the general population. The focus of this workshop will be on the school's responsibility to keep students safe and how parents can work with schools in preventing bullying. We will also discuss what happens when bullying limits a student's ability to receive a free and appropriate public education (FAPE). **(2 hours) Also available in Spanish**

### ***Individualized Education Program IEP: Blueprint for Success (Pre-school and Elementary)***

Each public-school child who receives special education and related services must have an IEP designed to meet his/her unique needs. This step by step walkthrough provides an overview of the major components in Rhode Island's IEP form for children ages 3-13. **(2 hours) Also available in Spanish**

### ***Individualized Education Program IEP: Blueprint for Success (Secondary Transition)***

This workshop provides an overview of the major components of the IEP as well as a step by step walkthrough of Rhode Island's IEP form. The workshop also covers the Secondary Transition IEP for students 14 years or older and includes post-school goals in areas of employment, education and training and where appropriate, independent living skills. **Prerequisite: Basic Rights in Special Education (2 hours) Also available in Spanish**

### ***Pathways to Adult Services***

For consumers and families to make informed decisions about life after high school, information is needed to understand Rhode Island's adult service system for individuals with developmental disabilities. This workshop provides parents and families with a basic overview of adult services. Participants will explore a variety of options to help guide decision making to direct supports and services to create a meaningful life. **(2 hours)**

### ***Section 504: A Parent's Guide***

A basic overview of Section 504 will be discussed along with basic changes to the law. ### ***Section 504 after High School: College & Career***

**There are no IEP's after high school!** Whether students receive services through a 504 Plan or an Individualized Education Program (IEP), parents of youth (and youth themselves) will receive information about the legal background of disability laws. In addition, participants will learn the process for securing needed services and accommodations under Section 504/ADAAA. **Parents and students** are encouraged to attend this valuable training with their high school student **(2 hours) Prerequisite: Section 504: A Parent's Guide.**

### ***Skills for Effective Parent Advocacy***

Every parent wants to see their child happy, healthy, and part of their community. The goal of this presentation is to empower parents so they can become effective advocates for their children and receive the services their child needs. ### ***RI Medicaid Options for Families of Children with Special Health Care Needs***

This training provides families with the tools necessary to navigate the political arena and advocate for their children. Participants will learn the fundamentals of government, how to compose letters to elected officials and provide testimony, thus enhancing their advocacy skills. **(2 hours)**

**SEAC Strategies for Success:  
Building Special Education Local Advisory Committees  
Parent Leadership Training**

Rhode Island Parent Information Network (RIPIN) is offering an exciting training opportunity for Special Education Directors and the districts/schools they lead. Rhode Island has always valued home/school collaboration at the local level and shows its commitment to parent involvement by **mandating local special education parent advisory committees through state statute**. Rhode Island's legal requirement gives all districts the responsibility and authority to ensure parents have the opportunity to be involved.

As Rhode Island's federally designated **Parent Training and Information Center**, RIPIN has provided technical assistance to districts for over 25 years, specifically in supporting ways to improve outcomes for students with disabilities. In order to support those efforts, we have created a **15 hour training curriculum** for parent leaders.

Topics in this curriculum include: *Background & Basics, Recruiting & Retaining Members, Developing a Mission Statement, Strategies for Disseminating Information, Collaborative Leadership and Partnership, By-Laws, Running a Meeting and Prioritizing Needs and Setting Goals.* The target audience for this comprehensive training includes:

1. Current parent leaders within local advisory committees
2. Identified future parent leaders within a school district
3. District teams of 4-5 parent leaders developing a Local Advisory Committee
